Section A – Information to share with GP Trainees

Claims Queries

Practice Managers, Trainers and Trainees are asked to please raise GP Claims queries with the GP Claims Administrator, Shirelee Rebeiro at srebeiro@kss.hee.nhs.uk. Shirelee will investigate your query with Shared Business Services (SBS) as appropriate and re-submit any appropriate paperwork. The system only accepts claims which are completed fully and on the correct paperwork, and Shirelee can help ensure that things go smoothly for you, meaning faster payments. Please do **not** submit your claims direct to SBS.

Complaints, Significant Events and Serious Untoward Incidents

GP trainees need to be aware that they **must** declare any complaints, significant events (of a significant nature) and serious untoward incidents in which they are personally involved on their

Form R submission, which is a requirement in advance of their ARCP process. Form R informs decisions regarding their suitability for revalidation as a doctor, made by the Dean Director, as their Responsible Officer. Trainees should ensure that every such incident is accompanied by a detailed reflective entry in their e-portfolio, particularly focusing on whether the issue has been resolved, and what they have learnt from the encounter. Failure to complete such an entry can lead to delays in revalidation.

When to take CSA and AKT exams

All trainees should be aware of the need to ensure they have taken the AKT and CSA exams within their training programme, allowing time for the results to be available **before** their programme ends. Since the CSA is now available every month from October to May, this should be straightforward, and we would strongly recommend not leaving exams too late in training. It would be expected that trainees who have not put themselves in a position to have passed both exams by the end of their training would not be offered any extension to their training, as this is a basic requirement of their training.

It's also worth considering that February and March are likely to be very popular months for trainees to apply to sit the CSA, and to avoid disappointment they should consider applying as early as possible. Changes to DOPS assessments – ACTION REQUIRED BY ALL

The RCGP have acknowledged that the mandatory DOPS assessments are too limited in scope to accommodate the learning needs of all trainees. With this in mind, this year <u>in addition</u> to completing the mandatory DOPS, a new category of 'integrated DOPS' will demonstrate a new competency: 'clinical examination and procedural skills'. During the first year of this process – i.e. until July 2015 BOTH assessments need to be documented on the e-portfolio, when the new Integrated DOPS will be evaluated.

Section B – Information for Faculty (Programme Directors / GP Trainers)

Changes in circumstances

The GP department needs all trainers to keep them fully informed of any changes in their circumstances – for example when moving practice, taking a sabbatical, moving premises, changes in practice manager etc. The GMC maintain a list, which is now available to the public, detailing all accredited GP trainers and practices, and therefore need to be informed when changes occur. It is therefore a professional responsibility to ensure that the data they hold remains accurate. We appreciate that trainers are likely to keep their GPST administrators and Programme Directors informed, but would ask that you also inform your patch manager when changes arise, please.

Trainees in a GP placement: Pilot to Streamline SEAT GP Trainer Grant processes

As you may know, we are piloting a system to make payment the Trainer Grant easier where the training practice hosts a trainee employed under the Single Employer (Acute Trust) process. This should reduce the administrative burden on practices, but does rely on trainers/practices completing the necessary paperwork in a timely manner.

In order to benefit from this please ensure you have completed the Trainer SLA for each period when a trainee is hosted in the practice. From August 2014 placements, the trainer grant is paid on receipt of the GP Trainer SLA – no invoice required – payment will be made direct into the practice bank account. There are still a number of SLAs outstanding from August 2014 – please send it in to ensure you get paid.

GP Trainers will need to complete the following documents when hosting a SEAT employed GP Trainee:

- <u>GP Trainer SLA for SEAT GP Trainees</u> to be completed and sent in to the GP School
- Joint Honorary, and Educational Contract for SEAT GP trainees to be signed and copy
 retained in the practice

Claiming Educational Supervisor Grants for GPST1 & ST2: Trainees in Hospital Placements 2014-15

GP Trainers who have taken on Educational Supervisor responsibility for GPST1 and GPST2 Trainees from **August 2014**, are invited to claim a one-off payment of £500 per trainee (per 12 months pro rata) when placed outside of the GP practice, in recognition of this additional responsibility. **(NB: This payment is not applicable to FY2 Trainee supervision).**

(Please note that the payment will be adjusted accordingly to account for any periods that the trainee spends in a GP Post at <u>your own practice</u> when this payment is superseded by the Trainer Grant). Please also, note that payments will not be made for periods when a Trainee is on maternity, paternity or adoption leave.

Criteria for payment:

- GP Trainers (ES) responsibility for GPST1/GPST2 trainees (Aug 2014-July2015)
- Supervision of trainee ONLY when placed outside the GP practice

Claiming for the ES grants:

Please note the following requirements when completing the form which will help us to expedite the processing of your claim:

- To be submitted using the Educational Supervisor claim form available to download from the website at: <u>http://kssdeanery.ac.uk/gp-trainer-resources</u>
- to be TYPED (handwritten claims can no longer be accepted)
- the trainees GMC number and full name must be included on the form
- payments can only be paid to the Practice Account and not to individuals
- the claim form must be signed before returning it to us.
