RCGP WPBA Update on approval of CEPS

We are really pleased to announce that the GMC has approved Clinical examination and Procedural Skills as an assessment in the GP trainee ePortfolio.

These have replaced Direct Observation Procedural Skills which no longer need to be completed by trainees.

This includes a section for Clinical Supervisors.

The ePortfolio will be updated in the New Year so that :

- 1. The DOPS evidence form is removed.
- 2. Any DOPS or Skills logs completed by the trainee are available as 'read only' pages.
- 3. The three questions asked of the ES during every review are updated (with the intention that the third question, which relates to the trainees competence in intimate examinations, should only be completed at the time of a trainees final review).

We will confirm the date for the ePortfolio changes as soon as we are able.

HEKSS Guidance on Social Media

The use of social media by doctors in training is increasing, particularly in areas that enhance learning, sharing of knowledge and developing professional relationships. The ethical principles that apply in your professional interactions also apply to social media. Many people may see what you post, and not necessarily those you intended to see it. Once posted, content can be very difficult to remove.

The GMC provides guidance on the use of Social Media based upon the principles of Good Medical Practice (2013). This guidance sets out the principles of maintaining boundaries and confidentiality, respect for colleagues and patients and issues of privacy and anonymity. Further <u>guidance</u> has also been produced by the British Medical Association that references the <u>GMC guidance</u> and has further information about protecting yourself online. Both sets of guidance are attached to this statement for information.

HEKSS expects doctors training within the region to follow these principles in their use of social media. Doctors in training should not use publicly accessible social media to discuss individual patients or their care with those patients or anyone else. It should not be used to discuss colleagues, supervisors or placements where there may be negative comments. In addition, most employers will have a social media policy to which you will be contractually compelled to adhere, as well as a process for escalating concerns about incidents that are witnessed in working environments.

HEE Change to payment process of GP Trainer grant from January 2016

Health Education England (HEE) finance team has confirmed that RTP payments (Ready to Pay transactions) will no longer be carried out from January 2016.

For GP training practices, this means that the current monthly process established with HEKSS for payment of the GP Trainer grant, for trainees employed under the Single Employer Acute Trust arrangement will, from January 2016 need to change.

From January 2016 the GP Trainer grant payment will revert to payment made on receipt of an invoice along with the HEKSS GP School Trainer SLA. A new guidance document, SLA and invoice are available here http://www.kssdeanery.ac.uk/gp-single-lead-employer. The SLA and invoice can be claimed for the total period of the trainee placement.

Transition period & payment:

We are pleased to inform you that we have agreed with the finance team that where a trainee placement has already commenced and where we are already in receipt of the Trainer SLA - finance will pay in the final RTP payment in December, the outstanding amount of the trainer grant up to the end of the placement period noted on the SLA (up to a cut-off date of August 2016).

Any extensions to a placement should be confirmed to the GP School on a new SLA and the trainer grant claimed by invoice for the extension period.

If trainers/practices have not yet submitted the Trainer SLA for a trainee placement that commenced prior to the end of December 2015 the new process of invoicing will apply. Thank you for your support in helping us to implement this new process.

Dyslexia assessments

As part of our integration with London, HEKSS is now able to refer trainees with AKT failures for a dyslexia assessment. To discuss any trainee whom PDs think might benefit from this, or another more specialist assessment, please contact your Patch Associate Dean.
