<b>Department</b>	The Clover Street Clinic provides integrated sexual healthcare to the population of Medway, including testing and treatment of sexually transmitted infections, HIV outpatient care, provision of contraception, psychosexual counselling and sexual health outreach. The medical team based at Clover Street consists of two Consultants (one Genitourinary Medicine and one Sexual and Reproductive Health), 1.5 WTE specialty doctors and 0.8 WTE GP Registrar).

There will always be experienced doctors and nurses on site working alongside you in clinic.</p> <p>You will be expected to attend FY2 teaching and departmental teaching whilst working in the service.
