Reflection

What was interesting or notable about this experience? What did I gain from it? What were the challenges?

I have really enjoyed completing workbook two. It has led me to approach each interaction using a personal care plan. I did some eLearning which helped me understand this.

I went to our FY1 teaching from the PALS team. The talk was really interesting, but it was quite upsetting to hear about the challenges some patients have had. I found the talk from the patient who was not told about her diagnosis properly by her doctor particularly sad.

We also had some teaching on consent for bronchoscopy from our registrar. We went through the form so I understand this much better now. This will be helpful for when I am an FY2.

Overall, this module has taught me a lot. I really want to be a good foundation doctor and I think this will really help me with this. I will carry forward what I have learnt to FY2.

This trainee outlines their experiences but does not speak meaningfully about what they gained from them. The paragraph on PALS teaching gives the narrative of the teaching without discussing how this will change their practice.

Whist consent plays an important role in patient centred care, this trainee hasn't given enough detail about the teaching to show how it was relevant.

What did you learn about yourself and your abilities? How does this relate to your clinical practice and/or the delivery of patient care in your clinical area?

This module has taught me about the importance of properly listening to patients. This means they will feel listened to and improve their experience.	This trainee talks about their strengths and weaknesses at a surface level but does not explore them in enough depth.
On the ward we had an older patient who was upset about being in for a long time. We chatted about this and he felt much better afterwards. I was proud that I had helped him.	The example given is not specific. It does not tell the reader how this scenario is relevant to the module or what it has taught the trainee about their own skills.
Sometimes I struggle to explain things properly to patients and this is definitely something I would like to work on. I think I need to practice this as an FY2, where I will have more responsibility.

What next?

What can I do to build my knowledge or skills further? E.g., planning more practice or experience, move onto something more advanced.

As I mentioned above, I think I need to improve how I explain things to patients. I will do some more eLearning and read some articles about this.

I have a GP job in FY2, so I will have lots of practice on communicating with patients. I will talk to my supervisor about getting better at this and practice through the placement.

I will work towards being a better communicator.

I will talk to my supervisor about them watching me do some consultations. I will then use their feedback to improve my practice. I will also do some reading and eLearning too.

Overall, this reflection is superficial. It describes the trainees experience but not what they have learned from them. Their goals are not specific enough and they do not use SMART objectives.

This section lacks specificity and detail. It does not show any planning or that the trainee has thought about how they will improve their skills.

Again, this lacks detail. It is not a SMART objective and does not give a clear target for the trainee to work towards.
